The Impact Aid Survey is designed to assist local school districts who have lost revenue due to Federal properties exemption from local property taxes. The survey collects examples of what Impact Aid funding is used for, the challenges that school districts face related to federally owned land, and how additional resources for federally impacted school districts can provide new opportunities to students and communities.
